# The W+ Standard



What it is: standard/certification framework that provides metrics and procedures to quantify, verify and monetize women's empowerment results within projects and supply chains.

#### Founded by WOCAN in 2015 to:

- 1. Increase rigor and accountability of gender policies/initiatives
- 2. Incentivize new investments and actions for gender, esp. in climate sectors
- 3. Create a new revenue stream for women's organizations
- ✓ Received the UNFCCC's Women for Results Momentum for Change Award in 2016
- ✓ First-ever, women-specific standard that measures women's empowerment in a transparent & quantifiable manner
- ✓ Quantifies commitments related to SDG #5
- ✓ Gives a monetary value to results and creates a market- & results-based financing mechanism
- ✓ Creates a new channel to direct financial resources to women project beneficiaries
- ✓ Is included in the Verified Carbon Standard (VCS/VERRA) to provide a label for a carbon credit

## What it measures



- The W+ Standard measures six domains critical for women's empowerment:
  - Time
  - Income & Assets
  - Health
  - Leadership
  - Education & Knowledge
  - Food Security
- These were determined together with rural women from Nepal and Kenya alongside gender experts. Methods were developed to measure and quantify progress for each of these domains.

Note: not all domains need to be used

### How it Works





1.Project is registered and certified with project activities benefiting women in 1 or more of 6 domains

2. W+ units a companies institutions

2. W+ units are sold to companies and other institutions

3. Women receive a minimum of 20% of the value of W+ unit sales, providing additional benefits through a direct channel of income

# Example: Transformative changes in women's lives in Nepal

- Govt. provided biogas units and measured/sold GHG units. Women's labor (unpaid) enabled functioning and maintenance of biogas digesters resulting in climate mitigation, forest conservation and GHG units.
- W+ Standard measured the time saved for 7,200 who replaced their wood-generated stoves, relieving them of the need to collect fuel wood from the forest and saving 2.26 hours per day.
- By eliminating this time-consuming, labor-intensive task, women gained time for leisure and self-improvement, planting vegetable gardens, and engaging in income generation and community activities.
- Women's groups received revenue from W+ unit sales, used for livelihood and climate adaptation activities.







# Value of the W+ Standard for Climate Finance



### **Activities**

- Enhance project design for gender and women's empowerment, using W+ Standard as design and monitoring framework
- ▶ Use as a screen across portfolios of climate investments to assess performance for gender Revenue source for sustainability of projects' gender
- Measure and report on results within climate projects funded by the GCF, development organizations, companies and private sector climate funds
- generate W+ units or W+ labeled carbon units

### Results

- ➤ Increased gender integration for outcomes, with qualitative metrics beyond numbers of women
- ➤ Increased accountability, transparency and confidence that projects and activities are producing results that include and benefit women, avoiding risk of 'pink washing'
  - Revenue source for sustainability of projects' gender activities through sale of W+ units
- ➤ Provides revenue for both investors and women's groups through benefit-sharing mechanism for self-determined adaptation initiatives, thus:
- ➤ Provides mechanism for climate mitigation finance to fund adaptation responses by women
